

In March, **3** journalists were **released**.










#### TRIALS CALENDAR

#### OTHER DEVELOPMENTS

In March:

- Turkey court <u>ruled on 76-defendant case</u> in Turkish-Armenian journalist **Hrant Dink's murder**, acquitting 28 and sentencing 26 defendants.
- Several journalists were physically and verbally <u>assaulted</u> by the police while covering **Women's March**.
- Press Advertisement Agency (BİK) imposed a total of 22-days ad ban to 8 newspapers.

#### IPI welcomes Turkish Constitutional Court decision reversing greater state control over Anadolu news agency

Mar 2, 2021

IPI welcomed a ruling by Turkey's Constitutional Court blocking closer government control over the state-owned Anadolu news agency (AA). A 2018 decree had authorized the presidential office to conclude a contract with AA which grants the presidential office power to regulate the appointment of executives and as well as to supervise the budget, activities, organization and human resources management of the news agency.

#### Turkey journalists sentenced for reporting on Turkish military actions in Libya

IPI condemned the prison sentences handed down to two journalists in Turkey, Müyesser Yıldız and İsmail Dükel, over their critical reporting on military operations of Turkish armed forces in Libya. The court sentenced Oda TV news editor Yıldız to three years seven months and ten days, and TELE1's Ankara correspondent Dükel to one year and 15 days in prison for revealing documents regarding the national security.
