





In November:

- Turkey <u>announced</u> sanctions (10 Million TL) on social media companies incld. **Facebook, Twitter, Youtube** for declining to comply with social media law.
- <u>ECtHR ruled on</u> ten former **Cumhuriyet** journalists' application, found violation of Article 5 § 1 and of Article 10.
