

OTHER DEVELOPMENTS

In March:

- An indictment was <u>prepared</u> against 15 Kurdish journalists and one media worker arrested on June 16 on terrorism charges in Diyarbakır after 9 months 10 days in pretrial detention.
- Twitter <u>blocked</u> access to Birgün's news tweet on alleged violence in the military and Diken's news tweet about Feb 6 earthquakes following government complaints.
