

### **OTHER DEVELOPMENTS**

- On July 11, IPI <u>monitored</u> the first hearing of 17 Kurdish journalists and 1 media worker in Diyarbakır after a year in detention.
- Main opposition party CHP, announced unilateral termination of all official ties with broadcaster Halk TV. IPI Executive Board Vice-Chair & Turkey National Committee Chair Emre Kızılkaya <u>commented</u> on the development.
