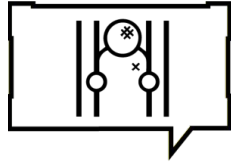

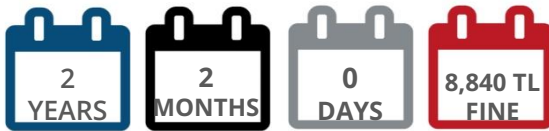

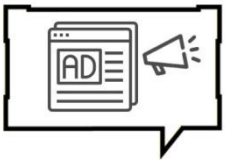
In September, **28** journalist trials were held. **1** journalists was acquitted, **3** journalists were sentenced:

### OTHER DEVELOPMENTS

- Journalists Abdurrahman Gök and Mehmet Şah Oruç who have been in pre-trial detention since April 27 appeared in court in Diyarbakır and Bitlis. Their pre-trial detention was [extended](#).

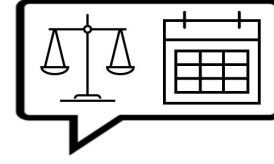

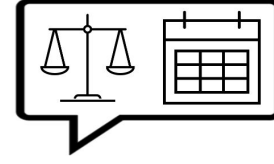

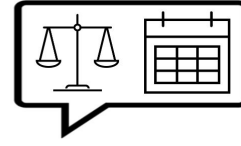
